| Citation | 1. This Order may be cited as the Local Authorities (Elections) (Preparation of Registers) (Revision of Time) Order 2023. |
| Purpose of this Order | 2. This Order provides for the extension of the period during which objections may be made, and the consequent revision of the dates for all subsequent activities, in the preparation of the registers of voters for each local authority area in accordance with the Local Authorities (Elections) (Preparation of Registers) Order 2023 dated the 8th day of February 2023. |
| Extension of time for objections | 3. The period for the making of objections, specified in paragraph 6(b) of the previous Order referenced in paragraph 2 above, is hereby extended so that it will conclude on 2 March 2023. |

Revision of
other times

4. Following the extension of the time for objections in paragraph 3 above, the following dates in the previous Order are also revised as follows:

(a) The date in paragraph 7 of the previous Order, for the sending of supplementary lists, etc, is changed to 4 March 2023.


(b) The date in paragraph 8 of the previous Order, for the hearing for objections, is changed to 4 March 2023.

(c) The dates in paragraphs 9 and 10 of the previous Order, for correction of the preliminary lists and correction of the supplementary lists respectively, are both changed to 16 March 2023.
